#### **Payment Options:**

\* Online Payment: You can conveniently pay your annual HOA dues online by visiting our website at <https://www.nisquallymeadowshoa.com/annual-dues>. Homeowners that choose this service, are agreeing to take the responsibility for the additional fee which will be: 2.9% of the total transaction amount plus 0.30 cents. If you pay with American Express you will be billed for extra fee associated with it. If you submit an electronic payment, and choose to cancel the payment after your submission, you will not be able to receive a refund of the fee amount that was paid. Please take note that a credit/debit transaction can take up to 3 days to process. When payment is made you will receive a receipt for the payment, please hold on to this for your records, as verification of payment. A payment will not be considered late, as long as it was submitted before the due date.

\* **Check/Money Order Payment:** If you prefer to pay by check, please make your check/money payable to Nisqually Estates HOA and send it to the following address: PO Box 2986, Yelm WA 98597 or make arrangements with a Board Member (Board: Melissa Worthington, April Newman, Michael Davenport, Sierra Thornberry, Valerie Vajda)

\*DO NOT take your dues payment directly to BECU. There is no way for us to tell who's payment belongs to who. We are not responsible for lost payments or payments we can not identify. Late fees will be attached.

#### **Important Dates:**

\* **Annual Due Date:** January 1st 2026

\* **Interest Starts:** January 15th 2026

\* **Next Billing** February 15, 2026

Interest will accrue at the rate of 12% per year or 1% per month for any portion thereof that is past due beginning January 15th, 2025.

\* **Lien Placement:** March 1st 2026

A lien could be filed for any existing balance beyond February 15th, 2026. If not received by February 28th the account will be forwarded to the HOA Attorney to have a lien placed on the property. All costs associated with the lien and the attorney are the responsibility of the homeowner.
